THE FRICK PITTSBURGH ANNOUNCES ELECTION OF NEW BOARD OFFICERS AND TRUSTEES

PITTSBURGH, PA, April 7, 2021 – At its recent annual meeting, the Board of Trustees of The Frick Pittsburgh elected officers for 2021–2022 and three new trustees. David Burstin was reelected to serve as Board Chair for a third term, and Edward H. Dane and Robert M. Hernandez were elected to serve as Vice Chairs. This marks Mr. Dane’s second term while Mr. Hernandez was newly elected. Reelected as Board Officers were Nancy Bromall Barry, Treasurer, and Steve Pavsner, Secretary.

The Board includes Family Trustees (descendants of Henry Clay Frick) and Term Trustees. Paul T. Harper, Ph.D., Russell Livingston, and Maureen M. Staley were elected to serve as Term Trustees at the Board’s March meeting.

Term Trustee **Paul T. Harper** is a Clinical Assistant Professor of Business Administration at the University of Pittsburgh’s Katz School of Business, where he is a member of the Organizations and Entrepreneurship faculty group. Dr. Harper has developed a research agenda around racial justice where he is interested in understanding the social policies and economic forces that continue to challenge the flourishing of U.S. domestic minority professionals and entrepreneurs. Additionally, Dr. Harper is widely known nationally and internationally for his work in building partnerships with burgeoning Israeli businesses and other technologically progressive countries through academic and professional engagement. He received his

Ph.D. and MBA from the Darden School of Business at The University of Virginia, and his M.A. from the University of Chicago Divinity School.

Term Trustee **Russell Livingston** is the President and CEO of Babb Inc., a Pittsburgh-based insurance broker, third-party administrator, and consultant to employers. Livingston is actively involved in the non-profit community and serves or has served on the Boards of March of Dimes, Young Life Fox Chapel, the Passavant Memorial Homes Foundation, and the Executive HeartWalks Leadership Team for the American Heart Association. He received his BA in Business from Westminster College.

Term Trustee **Maureen M. Staley** is a printmaker, and co-owner of the lifestyle boutique The Picket Fence in Pittsburgh's Shadyside neighborhood. At the Rhode Island School of Design, she received her undergraduate degree in printmaking and art history, participated in programs at the Chicago Institute of Art and the Tamarind Institute in Albuquerque, New Mexico, and was honored as a top printmaker in her final two years of study. Staley worked with many leading artists during her time at Gemini G.E.L. in Los Angeles, and received her MFA from Claremont Graduate University .
